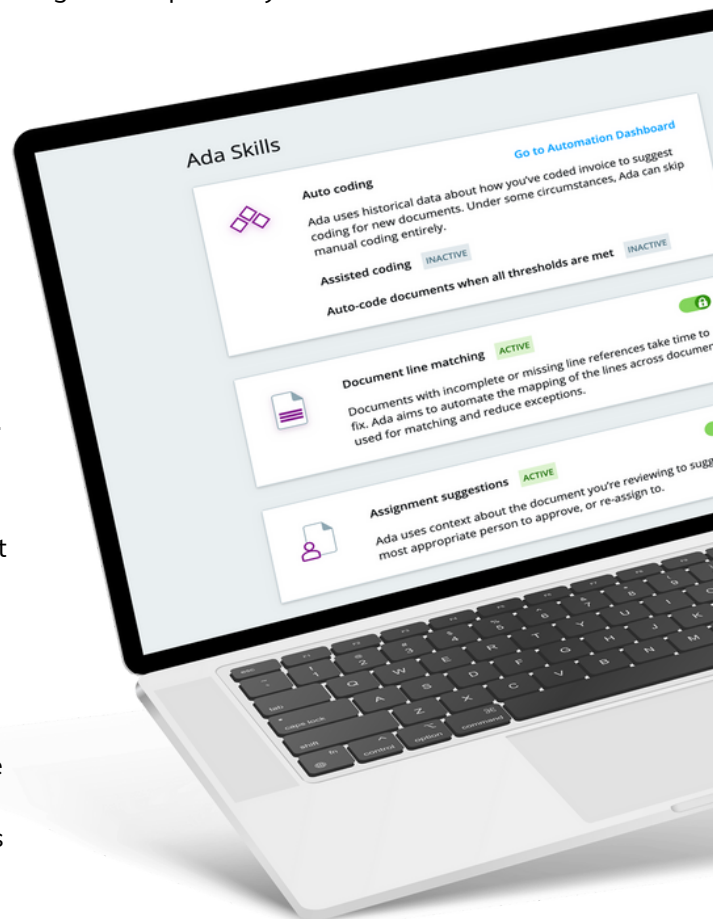

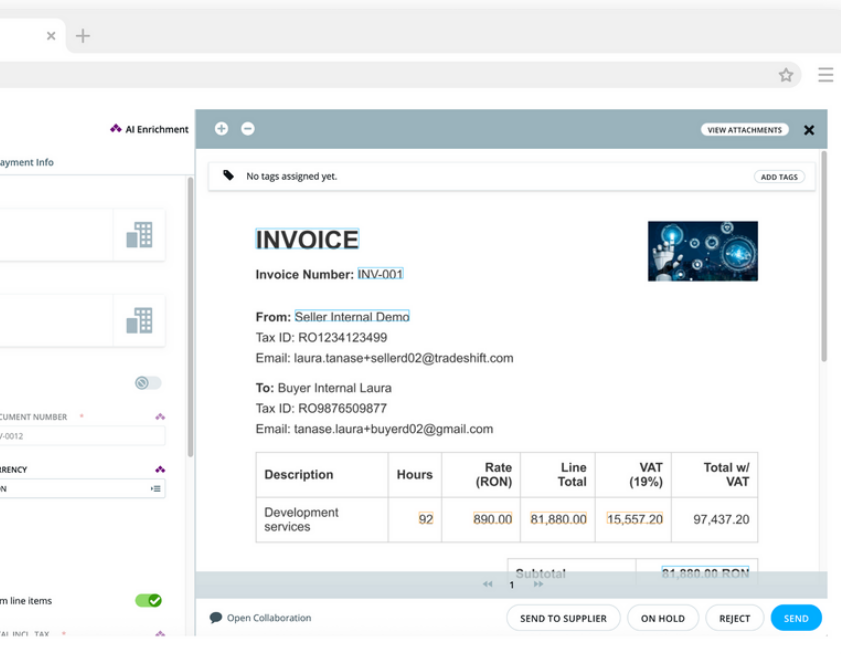
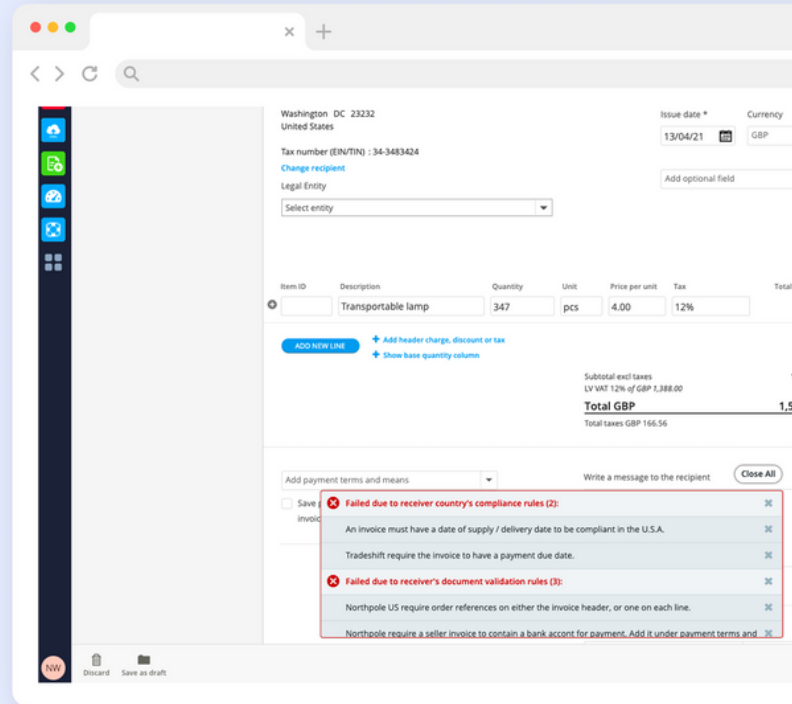
Tradeshift's Business Firewall

Our highly accurate AI suggestions are powered by Amazon Bedrock, utilizing the latest Claude model from Anthropic.

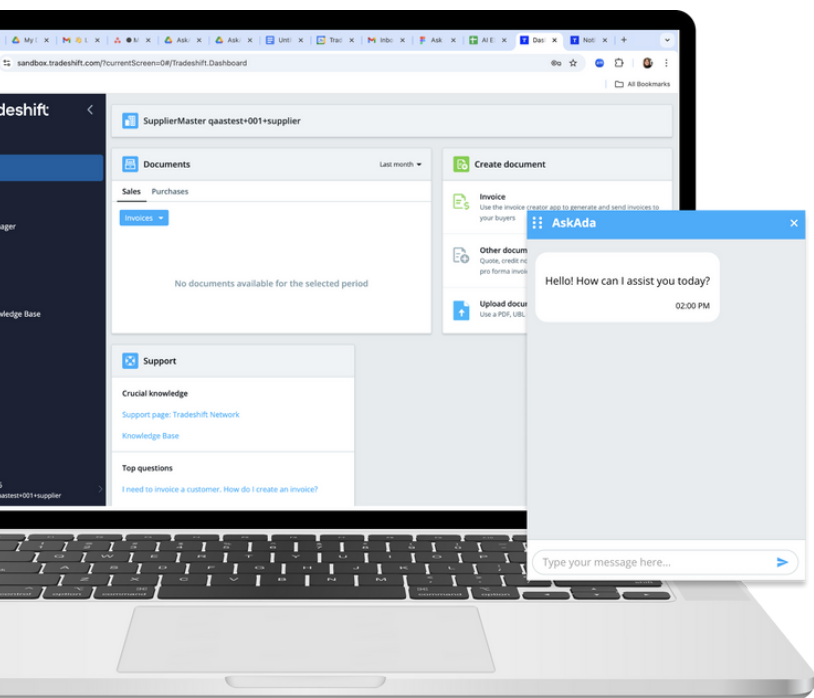
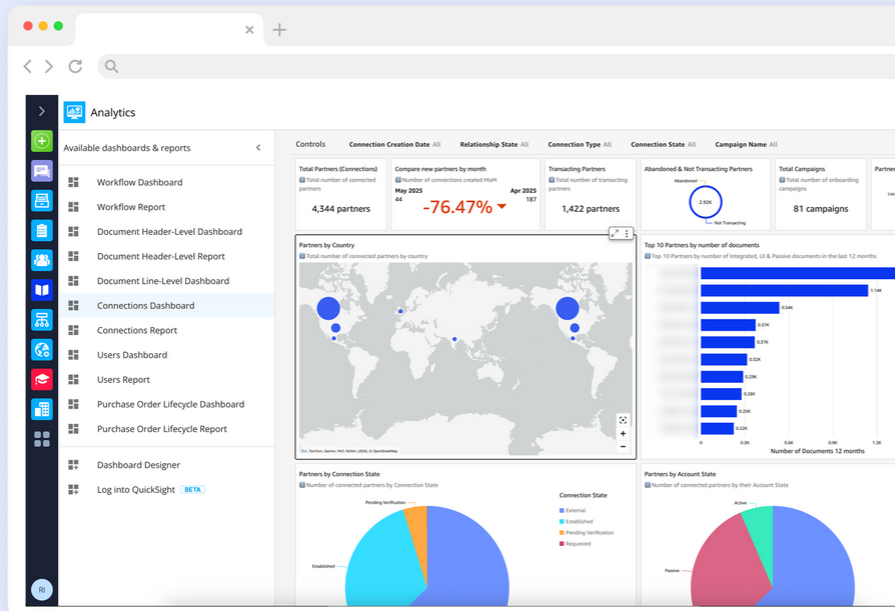
This advanced AI captures critical details like quantities, pricing, tax information, and performs line-level purchase order (PO) matching with precision from the very first transaction or PDF.
